- (b) Pilots or others hiring aircraft;
- (c) Passengers for or without reward;
- (d) All persons using aircraft or property owned, controlled or used by the Club.

The Club shall mean; LETABA FLYING CLUB - TZANEEN

In consideration of the Club granting me facilities for flying, tuition for flying and/or hiring of aircraft or allowing me the use of the aircraft, or other property owned or controlled or used by the Club, I agree: -

1. That I will at all times obey and comply with all Navigation laws, by-laws and regulations applicable to the Republic of South Africa as well as any special flying regulations imposed by the Club, and any special instructions conveyed to me by instructors or authorised officials.
2. That under no circumstances whatsoever shall the Club, it's servants, agents or other members be held responsible for or liable for any damage or otherwise, for any loss, damage or expense suffered by me or my estate or anyone claiming by or through me, due to or arising from the granting of the said flying facilities and/or the hiring of aircraft and/or the use of aircraft and/or any property or premises owned or controlled by the Club, notwithstanding that such loss or damage shall have been caused through negligence. I agree to indemnify the Club in respect of any such claim.
3. That I indemnify the Club against all losses, damage or expense which the Club may suffer or be called upon to pay whether for damage or otherwise arising from my conduct or act or omission in connection with or arising out of the use of any aircraft loaned or supplied by the Club to me, or the use by me of any property or premises owned, controlled or used by the Club, and I agree that this indemnity shall apply to the conduct, act or omission of any person who shall have been invited by me to use the said aircraft, property or premises.
